Dear Parishioners of St. Patrick's Church,

I continue to find great consolation through your continued faith, commitment to our parish community and financial generosity. It is a pleasure to serve as your pastor, and I am grateful be at the Church of St. Patrick.

I am happy to report that numbers of young families are rising at St. Patrick's. We are experiencing helpful feedback regarding our programs for preschool and elementary faith formation through Confirmation. It continues to be a challenge to hire any youth Ministers as the shortage is an Archdiocese wide situation. We are collaborating with Our Lady of Grace on high school programs.

Our Finance council has set a new Liquidity goal for our parish. In the next couple of years, we would like to reach 10 months' Liquidity. We are currently near the minimum at 6.5, which is wonderful. Offertory donations met our budget again this year. Thank you for your generosity and support. My staff monitors expenses to keep our monthly purchases as low as possible, which costs approx. \$117,000.

In addition, our congregation has been generous to specific projects: a new tabernacle and sound system in the church. Classroom improvements for the Catechesis of the Good Shephard program, as well as maintenance and grounds improvements are complete. You have been generous in our outreach to the poor: VEAP food shelf, Veterans clothing collection, and Guatemalan Coban water filter donations which helped many this year. Congratulations on living your faith through your generosity in outreach as well as for the Parish Community. The Garage Sale was an extreme success this year through hard work, dedication, and donations. I appreciate all you do emulating Jesus in your lives.

In addition to the Liquidity Fund, we are striving to increase our Permanent Endowment Legacy Fund. With our matching program last year and a sound investment strategy we have \$153,949 in the Fund. A financial legacy gift to St. Patrick's will positively affect future generations. Please consider a bequest to St. Patrick's.

I continue to pray for you and your families as we continue our spiritual journey together. I'm confident that we will have another wonderful year together at the Church of St. Patrick. Respectfully,

LEGACY GIFT PROGRAM

PERMANENT ENDOWMENT

A Permanent Endowment is a fund which is held in perpetuity with a trustee where annual distributions are paid to provide regular support for a beneficiary organization. The Church of St. Patrick's Permanent Endowment is designed to provide stable, ongoing financial support to our parish community. The principal is legally protected and cannot be withdrawn.

LONG TERM LIQUIDITY FUND

This fund has no legal restrictions to hold the funds permanently. As with the Permanent Endowment, the principal grows through prudent investing. The principal and interest can be accessed at any time, and in any amount at the discretion of the parish, understanding that funds may be subject to donor restrictions or intent.

5 Ways to Support the Legacy Gift Program

<u>Cash or Stock</u> - Give any amount, any time! Make checks out to the Church of St. Patrick. Indicate whether the gift is for the Long-Term Liquidity Fund, the Permanent Endowment, or some split between the two (e.g. 40% LT Liquidity, 60% Permanent). Gifts of stock are converted to cash, and value is added to our fund.

Bequest in Your Will or Estate Plan - You can include St. Patrick's in your will or estate plan by designating a specific dollar amount or percentage of your estate as a gift.

<u>Charitable Gift Annuity (CGA)</u> - A CGA provides you with regular payments for the rest of your life. At the end of your life, the remaining balance of your annuity becomes a charitable gift to either of the 2 funds. A minimum gift of \$10,000 is required to establish a CGA at the Catholic Community Foundation of Minnesota.

<u>Life Insurance or IRA Beneficiary Designations</u> - You may name St. Patrick's as a full or partial primary or contingent beneficiary on your life insurance policy. In the case of retirement plan assets, such as an employee plan, IRA, or tax-sheltered annuity, your beneficiaries will owe income tax on these assets. Donating even a percentage of your plan can provide a significant tax benefit.

<u>Donation of Real Estate</u> – Almost any type of real estate may be donated, including a personal residence, commercial building, vacation home, undeveloped land, or farmland.



The Church of St Patrick's permanent endowment is stewarded by the Catholic Community Foundation of Minnesota (CCF) in accordance with current laws and evolving best practices. CCF employs faith-based investment practices in line with the Socially Responsible Investment Guidelines of the US Conference of Catholic Bishops.



As the Church of St. Patrick enters its second year of our 3-Year Strategic Plan, we would like to share with you the results of Year 1 and our priorities for Year 2:

2024-2025 STRATEGIC PRIORITIES

OBJECTIVE 1: Grow the number of active parishioner households from 600 to 800 within three years. *Year 1 Target:* 50 New Households; Results: 47 New Households versus 34 in the Prior Year

OBJECTIVE 2: Increase the financial participation of contributors from 60% to 90% of parishioners over the next three years.

Year 1 Target: 70% Participation; Results: 70% Participation versus 64% in the Prior Year

OBJECTIVE 3: Expand and deepen the faith formation experience across all age groups. *Year 1 Target:* Middle & High School Programs; Results: Partnered with Our Lady of Grace to work together with Confirmation Candidates supported by volunteers from the Women's and Men's Clubs

OBJECTIVE 4: Provide a framework for current leaders to mentor and support new and future volunteers through the development of a succession program.

Year 1 Target: Annual Garage Sale; Results: Set expectations early, provided resources, and worked together as a "TEAM". Financial results will be published later this month.

2025-2026 STRATEGIC PRIORITIES

OBJECTIVE 5: Grow the number of active parishioner households to 800 within three years.

Year 2 Target: 65 New Households

OBJECTIVE 6: Increase the financial participation of contributors to 90% of parishioners over the next three years.

Year 2 Target: 80% Participation

OBJECTIVE 7: Engage the youth of our parish wherever possible including liturgical roles, social events, and outreach to others, both inside and outside of our parish.

Year 2 Target: Organize 4-6 High School Events & Programs

OBJECTIVE 8: With a rich 168-year heritage as a Catholic community in Edina, the Church of St. Patrick stands strong and vibrant. The size and beauty of our church and its entire campus lends itself to several opportunities to serve and grow in new ways, reflecting the past, present, and future of our parish. *Year 2 Target:* Explore various possibilities to grow and serve by assessing the needs of our parish and the communities we serve to leverage the resources God has provided us.
